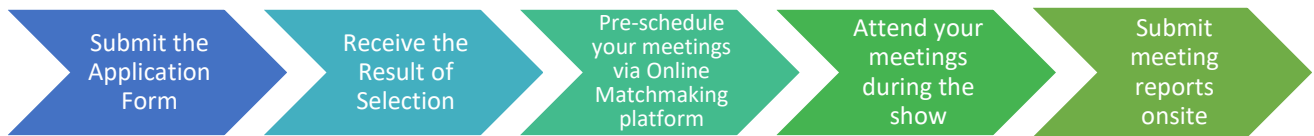

- ▶ By participating in Hosted Buyer Programme of CPHI & Hi Korea 2023, you automatically accept the following terms and conditions defined by the secretariat.

1. General

- ① Once you have been selected as a Hosted Buyer, you are not allowed to change the person in the list to other. (Exceptions are made only when a person of higher position comes.)
- ② Overview of Hosted Buyer Programme process is as follows;



- ③ Who qualifies:
- Applicants in charge of planning or making purchase decisions to source Pharma and Bio-related/Health Ingredient products and services
 - Applicants wishing to promote their sales will not be accepted into this programme.

2. Hosted Buyers will be committed to:

- ① Attend **at least six (6) verified meetings** with exhibitors during **at two (2) days of attendance** of CPHI & Hi Korea 2023.
- Hosted Buyers may pre-schedule their meetings via Online Matchmaking System at their discretion. The login details will be emailed from the secretariat.
 - Attendance at meetings onsite may be monitored by an assisting staff in the venue to prevent non-attendance.
- ② Hosted Buyer should be punctual and ready before the meeting has started.
- Buyers not in the meeting on time may have a disadvantage when they apply for the next year Hosted Buyer Programme.
- ③ Attend 15-20 minutes interview with the secretariat to present Meeting Report to verify their meetings.
